### APPEAL OF THE MONTAGNARD FOUNDATION AND FROM THE DEGAR MONTAGNARD PEOPLE IN VIETNAM'S CENTRAL HIGHLANDS TO THE INTERNATIONAL COMMUNITY: OVER 200 PRISONERS OF CONSCIENCE SHOULD BE IMMEDIATELY RELEASED

**The Montagnard Foundation and the indigenous Degar Montagnard People makes this appeal to the international community in order to peacefully resolve the human rights situation facing the Montagnard in Vietnam's Central Highlands. The Montagnard Foundation calls on the United States, the European Commission, the United Nations and Vietnam's donor nations to pressure Vietnam to:**

#### **1. OPEN THE CENTRAL HIGHLANDS TO INTERNATIONAL MONITORS**

Since Vietnam and the United States are currently engaged in trade agreements and discussing strategic partnerships for defense, there is now no reason for the Vietnamese government to view the Degar Montagnard people as an enemy because of Montagnard support to the US Armed Forces during the Vietnam War.

#### **2. WITHDRAW ITS TROOPS FROM THE CENTRAL HIGHLANDS**

Since Cambodia and Laos are allies of Vietnam and all the Degar Montagnard refugees in Cambodia have been forcibly repatriated, there is no longer any reason for the Vietnamese military to continue to occupy the Central Highlands. Currently the Vietnamese government views the ethnic Degar Montagnard people as their worse enemy. We request that the soldiers and Cong An security forces desist in security operations and withdraw their soldiers from the Central Highlands. The Degar Montagnard people only desire to be treated as equal citizens in Vietnam.

#### **3. RELEASE ALL DEGAR MONTAGNARD PRISONERS OF CONSCIENCE**

Since the Vietnamese government claims it does not harm the Degar Montagnard refugees who have been forcibly repatriated to Vietnam from Cambodia, there is no longer any reason for Vietnam to keep other Degar Montagnard people in prison. We request the government of Vietnam release all Degar Montagnard prisoners who have been arrested and imprisoned since the Montagnard peaceful demonstration of 2001.

***All of the indigenous Degar Montagnard prisoners who are listed below have been tortured and imprisoned not because they are terrorists or wanted to overthrow the government of Vietnam or wanted an independent state but simply because they dared to stand up and ask for the respect of their basic human rights, indigenous land rights and religious freedom. We humbly ask all of Vietnam's donors to not empower Vietnam with aid money unless the persecution against the Montagnards ceases.***

1 – Y-Srun Butrang (male), age 46, from the village of Buon Jun Yuh, district of Dakmil, province of Daknong. He was arrested and imprisoned on April 10, 2004 and the date of trial unknown but has been sentenced 11 years to prison in Ha Nam.



2 – Y-Thot Butrang (male), age 41, from the village of Buon Jun Yuh, district of Dakmil, province of Daknong. He was arrested and imprisoned on April 10, 2004 and date of trial unknown but has been sentenced 11 years to prison in Ha Nam.



3 – Y-Het Bupah (male), age 32, from the village of Buon Jun Yuh, district of Dakmil, province of Daknong. He was arrested and imprisoned on April 10, 2004 and date of trial unknown but has been sentenced 11 years to prison in Ha Nam.



4 – Y-Tlup Adrong (male), age 52, from the village of Buon Kmrong Prong, district of Buonmathuot, province of Daklak. He was arrested and imprisoned on October 21, 2003 and date of trial unknown but has been sentenced to 8 years to prison in Ha Nam.



5 – Y-Nging Nie (male), age 30, from the village of Buon Poc, district of Cu Mgar, province of Daklak. He was arrested and imprisoned on August 10, 2004 and date of trial unknown but has been sentenced to 6 years to prison in Ha Nam.



6 - Y-Thim Buonya (male), age 38, from the village of Buon Ko Tam, district of Buonmathuot, province of Daklak. He was arrested and imprisoned in 2001 and date of trial unknown but has been sentenced 10 years to prison in Ha Nam.



7 – Y-But Nie (male), age 32, from the village of Buon Ea Sang, district of Cu Mgar, province of Daklak. He was arrested and imprisoned on April 10, 2004 and date of trial unknown but has been sentenced 10 years to prison in Ha Nam.



8 – Y-Nok Mlo (male), age 33, from the village of Buon Ktla, district of Krong Buk, province of Daklak. He was arrested and imprisoned on February 6, 2001 and date of trial was on September 26, 2001 sentenced 8 years to prison in Ha Nam.



9 – Y-Dham Knul (male), age 41, from the village of Buon Sah, district of Krong Ana, province of Daklak. He was arrested and imprisoned on September 16, 2002 and date of trial unknown but has been sentenced 6 years to prison in Ha Nam.



10 – Y-Duk Eban (male), age 26, from the village of Buon Nui, district of Cu Jut, province of Daknong. He was arrested and imprisoned on April 10, 2004 and date of trial unknown but has been sentenced 10 years to prison in Ha Nam.



11 – Y-Thomas Ya (male), age 50, from the village of Buon Budak, district of Dakmil, province of Daknong. He was arrested and imprisoned in 2001 and date of trial was on October 29, 2002 sentenced 8 years to prison in Ha Nam.



12 – Y-Klong Nai (male), age unknown, from the village of Buon Draï, district of Ea Hleo, province of Daklak. He was arrested and imprisoned on February 16, 2001 and date of trial unknown but has been sentenced 8 years to prison in Ha Nam.



13 – Y-Rit Nie (male), age 32, from the village of Buon Poc, district of Cu Mgar, province of Daklak. He was arrested and imprisoned on April 10, 2004 and date of trial unknown but sentenced 15 years to prison in Ha Nam.



14 – Y-Ngun Knul (male), age 37, from the village of Buon Ecam, district of Krong Ana, province of Daklak. He was arrested and imprisoned on April 20, 2004 and date of trial unknown but has been sentenced 15 years to prison in Ha Nam.



15 – Y-Kuo Nie (male), age 51, from the village of Buon Ja, district of Krong Bong, province of Daklak. He was arrested and imprisoned on September 6, 2002 and date of trial unknown but has been sentenced 7 years to prison in Ha Nam.



16 – Y-Krec Buonya (male), age 27, from the village of Buon Poc, district of Cu Mgar, province of Daklak. He was arrested and imprisoned on July 20, 2002 and date of trial unknown but has been sentenced 8 years to prison in Ha Nam.



17 – Y-He Eban (male), age 59, from the village of Buon Kdun, district of Buonmathuot, province of Daklak. He was arrested and imprisoned in 2002 and date of trial unknown but has been sentenced 8 years to prison in Ha Nam.



18 – Y-Tan Nie (male), age 53, from the village of Buon Ea Tieu, district of Krong Ana, province of Daklak. He was arrested and imprisoned on April 20, 2004 and date of trial unknown but has been sentenced 9 years to prison in Ha Nam.



19 – Y-Kim Enuol (male), age 41, from the village of Buon Ea Tieu, district of Krong Ana, province of Daklak. He was arrested and imprisoned in 2002 and date of trial unknown but has been sentenced 9 years to prison in Ha Nam.



20 – Y-Jon Enuol (male), age 29, from the village of Buon Kdun, district of Buonmathuot, province of Daklak. He was arrested and imprisoned in 2002 and date of trial unknown but has been sentenced 8 years to prison in Ha Nam.



21 – Y-Jim Eban (male), age 41, from the village of Buon Sut Hluot, district of Cu Mgar, province of Daklak. He was arrested and imprisoned on April 19, 2004 and date of trial unknown but has been sentenced 8 years to prison in Ha Nam.



22 – Y-Druk Nai (male), age 35, from the village of Buon Sek, district of Ea Hleo, province of Daklak. He was arrested and imprisoned on February 16, 2001 and date of trial was September 26, 2001 sentenced 7 years to prison in Ha Nam.



23 – Y-Het Niekdam (male), age 47, from the village of Buon Ea Tieu, district of Krong Ana, province of Daklak. He was arrested and imprisoned in 2002 and date of trial unknown but has been sentenced 9 years to prison in Ha Nam.



24 – Y-Bri Enuol (male), age 47, from the village of Buon Dha Ea Bong, district of Buonmathuot, province of Daklak. He was arrested and imprisoned in 2002 date of trial unknown but has been sentenced 9 years to prison in Ha Nam.



25 - Y-Kur Buon Dap (male), Age 34, from the Village Buon Ea Khit, District of Krong Ana, Province of Dak Lak. He was arrested and imprisoned on August 20, 2004 at the Radio station in Dak Lak. He has not been tried yet.



26 - Y-Ruih Eban (male), Age 45, from the Village Buon Kdun , District of Buonmathuot, Province of Dak Lak. He was arrested and imprisoned on February 24, 2004 at the Radio Station in Dak lak. He has not been tried yet.



27 - Y-Hoang Buon Krong (male), Age 31, from the Village Buon Cuor Knia, District of Buon Don, Province of Dak Lak. He was arrested and imprisoned on August 15, 2003 at the Radio Station in Dak Lak. He has not been tried yet.



28 - Y- Not Eban (male), Age 31, from the Village Buon Pu Hue, District of Krong Ana, Province of Dak Lak. He was arrested and imprisoned on April 4, 2004 at the Radio Station in Dak Lak. He has not been tried yet.



29 - Bom Jona (male), age 49, from the village of Plei kueng grai, district of Dakdoa, province of Gia Lai. He was arrested and imprisoned on February 6, 2001 and date of trial was September 26, 2001, sentenced 12 years to prison in Ha Nam.



30 - Ksor Kroih (male), age 42, from the village of Plei Sor, city of Plei Ku, province of Gia Lai. He was arrested and imprisoned on February 6, 2001 and date of trial was September 26, 2001 and date of trial was September 26, 2001, sentenced 11 years to prison in Ha Nam.



31 - Ksor Alik (male), age 51, from the village of Plei Breng 1, district of Ia Grai, province of Gia Lai. He was arrested and imprisoned on April 24, 2004 and date of trial was May 30, 2005 sentenced 8 years to prison in Ha Nam.



32 – Puih Em, (male), age 50, from the village of Plei Ia Lang, city of Plei Ku, province of Gia Lai. He was arrested and imprisoned on September 28, 2002, and date of trial was November 20, 2002, sentenced 7 years to prison but don't know where. (no picture)



33 - Lat (male) age 41, from the village of Plei Nha Prong, city of Plei Ku, province of Gia Lai. He was arrested and imprisoned on July 15, 2002 and date of trial was September 27, 2002 sentenced 7 years to prison in Ha Nam.



34 - Rim (male) age 55, from the village of Plei la Lang, city of Plei Ku, province of Gia Lai. He was arrested and imprisoned on September 28-2002 and date of trial unknown but has been sentenced 6 years to prison in Ha Nam.



35 - Ksor Har (male) age 51, from the village of Plei la Gri, district of Plei Ku, province of Gia Lai. He was arrested and imprisoned in Aug of 2004 and he has been at the prison facility T-20 in Pleiku.



36 - Uui (male) age unknown, from the village of Plei Djrong, district of Dak Doa, province of Gia Lai. He was arrested and imprisoned on September 17, 2004 and date of trial unknown but has been sentenced 4 years to prison in Ha Tinh.



37 - Noh (male) age 46, from the village of Plei Dor II, district of Dak Doa, province of Gia Lai. He was arrested and imprisoned on June 11, 2003 the date of trial and the place of imprisoning are unknown. We believe he has been murdered.



38 - Ksor Hlun, (male) ega 37, from the village of Plei Ring, district of Dak Doa, province of Gia Lai. He was arrested and imprisoned on April 07, 2004 and date of trial was January 24, 2005 sentenced 11 years to prison in Ha Nam.



39 - Ksor Wung (male) age 36, from the village of Plei Dup, district of Dakdo, province of Gia Lai. He was arrested and imprisoned April 6 2004 and date of trial was January 24, 2005 sentenced 10 years to prison in Ha Nam.



40 - Siu Bler (male) age 43, from the village of Plei Al Hmoi, district of Dakdo, province of Gia Lai. He was arrested and imprisoned on August 26 2004 and imprisoned at T-20 in Pleiku.



41 - Prom (male) age 42, from the village of Plei Bia Bre, district of Dakdo, province of Gia Lai. He was arrested and imprisoned on February 12, 2001, and date of trial unknown but has been sentenced 8 years to prison in Thanh hoa.



42 - Rcom Ju (male) age 45, from the village of Plei Com Prong, district of Dakdo, province of Gia Lai. He was arrested and imprisoned on March 08, 2205, and imprisoned at T-20 in Pleiku.



43 - Croc (male) age 37, from the village of Plei Bia Bre, district of Dakdo, province of Gia Lai. He was arrested and imprisoned on September 19, 2002, date of trial unknown but he is now at the prison in Phu Yen.



44 - Ksor Rik (male) 35, from the village of Plei Bong Ngol, city of Pleiku, province of Gia Lai. He was arrested and imprisoned on September 08, 2004 and date of trial and imprisoning duration are unknown but he is now at the prison in Ha Nam.



45 - Ksor Wot (male) age 33, from the village of Plei Bong Phun, city of Plei Ku, province of Gia Lai. He was arrested and imprisoned on June 14, 2005 and date of trial and imprisoning are unknown but he is now at the prison in Ha Nam.



46 - Puih Pan (male) age 38, from the village of Plei Ciom district of Ia Grai, province of Gia Lai. He was arrested and imprisoned on September 15, 2004 and date of trial unknown but has been sentenced 2 years to prison in Phu Yen.



47 - Thup (male) age 53, from the village of Plei Dop, district of Dakdo, province of Gia Lai. He was arrested and imprisoned March 24, 2004 and date of trial was January 24, 2005 sentenced 10 years to prison in Ha Nam.



48 - Ksor Ti No (male) age 37, from the village of Breng 3, district of Ia Grai, province of Gia Lai. He was arrested and imprisoned on May 14, 2004 and date of trial was May 30, 2005 sentenced 7 years to prison in Ha Nam.



49 - Rahlan Ban (male) age 50, from the village of Plei O Yo, district of Dakdo, province of Gia Lai. He was arrested and imprisoned on Desember14, 2004 and date of trial and imprisoning are unknown but he is now at the prison in Phu Yen.



50 - Rmah Loih (male) age 41, from the village of Plei O Deh, district of Dakdo, province of Gia Lai He was arrested and imprisoned on January 5, 2005 and he has been imprisoned at T-20 in Pleiku ever since.



51 - Num (male) age 24, from the village of Plei Tuoh, district of Dakdo, province of Gia Lai. He was arrested and imprisoned on July 2, 2004 and date of trial was August 12, 2005 sentenced 12 years to prison but his whereabouts unknown. He might have been murdered.



52 - Ksor Blit (male) age 46, from the village of Bong Ngol city of Plei Ku, province of Gia Lai. He was arrested and imprisoned in 2003 and date of trial and duration for imprisonment are unknown but he is now at the prison in Ha Nam.



53 – Y-San Rmah (male), age 36, from the village of Buon Sam, district of Ea Hleo, province of Daklak. Date of arrest and trial unknown but he has been sentenced 8 years to prison in Ha Nam.



54 - Rahlan Beo (male), age 36, from the village Plei Kenh Hmek, district of Cu Se, province of Gia Lai. He was arrested and imprisoned in August of 2004 and date of trial and duration of imprisonment are unknown but has been sent to prison in Ha Nam.



55 - Rmah Treh (male) ge 40, from the Village Plei Kenh Hmek, district of Cu Se, province of Gia Lai. He was arrested and imprisoned on July 24, 2005 and he has been imprisoned at the prison facility in Cu Se District of Gia Lai Province.



56 - Rmah Hyuh (male) age 36, from the village of Plei Batel, district of Cu Se, province of Gia lai. He was arrested in July of 2002 and has been imprisoned at the prison facility of T-20 at Pleiku province of Gialai.



57 - Ksor Thiu (male) age 31, from the village of Plei Blang I, district of Ia Grai, province of Gia Lai. He was arrested and imprisoned in May of 2004 and date of trial was May 30, 2005 sentenced 7 years to prison in Ha Nam.



58 - Siu Chin (male) age 32, from the village of Plei O Yo, district of Dak doa , province of Gia Lai. He was arrested and imprisoned on March 8, 2005 and has been imprisoned at T 20 prison facility in Pleiku, province of Gialai.



59 - Rcom Kip (male) age 40, from the village of Plei Kia, district of Cu Se, province of Gia Lai. He was arrested on March 10, 2003 and date of trial unknown but has been sentenced 7 years to prison in Ha Nam.



60 - Puih Hui (male) 43, from the village of Plei Khun, city of Plei Ku, province Gia Lai . He was arrested and imprisoned on May 11, 2004 and date of trial unknown but has been sentenced 6 years to prison in Ha Nam.



61 - Mum (male) age 40, from the village of Plei DeThung, district of Dakdoa, province of Gia Lai. The date of arrest is unknown but he has been imprisoning at the prison facility T20 in Pleiku, province of Gialai.



62 - Kheng (male) age 45, from the village of Plei To Drah, district of Cu Se, province of Gia Lai. He was arrested and imprisoned on December 14, 2004 and date of trial unknown but he has been imprisoned at the prison in Tuy Hoa.



63 - Jum (male) age 43, from the village of Plei To Drah, district of Cu Se, province of Gia Lai. He was arrested imprisoned on December 21, 2003 but his whereabouts is unknown ever since. His family believes that he has been murdered by the Vietnamese police.



64 - Jim (male) 26, from the village of Plei To Drah, district of Cu Se, province of Gia Lai. He was arrested on January 16, 2005 and he has been imprisoned at the prison facility T20 ever since.



65 - Hlo (male) age unknown, from the village of Plei Pheo, district of Cu Se, province of Gia Lai. He was arrested and imprisoned on December 14, 2004, and date of trial unknown but has been imprisoned at the prison facility in Tuy Hoa.



66 - Y- Mpi (male) age 47, from the village of Bon Sarpa, district of Dakmil, province of Daknong. He was arrested and imprisoned on May 16, 2004 and date of trial are unknown but has been sentenced 5 years to prison. His present whereabouts is unknown. He might have been murdered by the Vietnamese police.



67 - Y- N'Krot (male) age 45, from the village of Bon Sarpa, district of Dakmil, province of Daknong, He was arrested and imprisoned on May 16, 2004 and date of trial unknown but has been sentenced 3 years to prison. He might have been murdered by the Vietnamese police.



68 - Kpa Grih (male) age 47, from the village of Plei Lao, district of Cu Se, province of Gia Lai. He was arrested and imprisoned on March 10, 2001 and date of trial unknown but has been sentenced 6 years to prison. He might have been murdered by the Vietnamese police.



69 - Kpuih Tin (male) age 37, form the village of Plei Djrek, district of Cu Se, province of Gia Lai. He was arrested and imprisoned in 2004 and has been imprisoned at T20 prison facility in Pleiku, province of Gialai ever since.



70 - Rcom Ba (male) age 47, form the village of Plei Het, district of Dakdoa, province of Gia Lai. He was arrested and imprisoned on December 9, 2004 and has been imprisoned at T20 prison facility in Pleiku, province of Gialai ever since.



71 - Kpa Anuit (male) age 37, form the village of Plei Hrai Dong, district of Cu Se, province of Gia Lai. He was arrested and imprisoned on November 16, 2004 and imprisoned at T20 in Pleiku, province of Gialai ever since.



72 - Rcom Djim (male) age 33, from the village of Plei O Yo, district Dakdoa, province of Gia Lai. The date of arrested and imprisoned unknown but he is now imprisoning at the prison facility T20 in Pleiku, province of Gialai.



73 - Ksor Krok (male) age 52, from the village of Bon Tul, district of Ia Pa, province of Gia Lai. He was arrested and imprisoned on June 28, 2004 and date of trial unknown but has been sentenced 7 years to prison in Ha Nam.



74 - Jrot (male) age 47, from the village of Plei Bia Bre, district of Dakdoa, province of Gia Lai. He was arrested and imprisoned on December 26, 2004 and date of trial unknown but he has been imprisoned at the prison in Phu Yen (no picture).



75 - Khoi (male) age 51, from the village of Plei Bia Bre, district of Dakdoa, province of Gia Lai. He was arrested and imprisoned on December 02, 2002 and his whereabouts is unknown but his family believes that he might have been murdered by the Vietnamese police (no picture).



76 – Y-Nuen Buonya (male), age 36, from the village of Buon Sup, district of Ea Sup, province of Daklak. He was arrested and imprisoned on February 6, 2001 and was tried and sentenced to 11 years prison on September 26, 2001. He is currently at the prison in Ha Nam (no picture).

77 – Y-Kao Buonya (male), age 41, from the village of Buon Sup, district of Ea Sup, province of Daklak. He was arrested and imprisoned on February 6, 2001 and was tried and sentenced to 7 years prison on November 19, 2001. He is currently at the prison in Ha Nam (no picture).
